Special efforts for extending coverage, creating awareness and providing greater convenience to the beneficiaries have been made in the North-Eastern States and Sikkim viz., introduction of home drug delivery service in ESIC Model Hospital, Beltola, Guwahati, holding a two-day zonal program and seminars & educational camps.

ESIC's participation in the All India Inter-Institutional Badminton Championship 2024 was a tremendous success, underscoring our commitment to promoting health and sportsmanship. National Sports Day 2024 was celebrated at ESIC Headquarters in New Delhi and at the Thyagaraj Sports Complex in Delhi, with 274 participants from Regional and Sub-Regional Offices actively taking part.

To further spread awareness of the ESI Scheme, various activities such as awareness camps and Suvidha Samagam were organized across the country. The 33rd All India Official Language Conference of ESIC was also concluded at Ernakulam, Kerala. ESIC achieved a landmark feat in medical science by conducting the first in-house cadaver organ retrieval, marking a significant advancement in its medical services capabilities.

Lastly, our provisional payroll data for May 2024 and June 2024 reveals that 23.05 lakh and 21.67 lakh new workers, respectively, were enrolled under the ESI Scheme, reflecting ESIC's expanding reach and growing impact on India's workforce.

ESIC Strengthens Medical Services through Convergence with PMJAY

On 20th August 2024, Dr. Mansukh Mandaviya, Hon'ble Union Minister of Labour and Employment chaired a meeting at the Employees' State Insurance Corporation Headquarters in New

Delhi. Mrs. Shobha Karandlaje, Hon'ble Minister of State for Labour and Employment was also present during the meeting.



The discussions primarily focused on enhancing medical services within the ESIC network and exploring potential avenues for convergence with the Pradhan Mantri Jan Arogya Yojana (PMJAY), India's flagship health insurance scheme. The goal of

this convergence is to create a more cohesive healthcare delivery system, ensuring better healthcare access and quality services for a wider range of beneficiaries.



ESIC HQ Hosts Crucial Meeting on Construction Projects and Healthcare Access

A significant meeting under the chairmanship of Dr. Mansukh Mandaviya, Hon'ble Union Minister of Labour and Employment was held at the Employees' State Insurance Corporation Headquarters, New Delhi on 21st August 2024. Mrs. Shobha Karandlaje, Hon'ble Minister of State for Labour and Employment

was also present during the meeting. The meeting was centered on key developments in ongoing construction projects and the formulation of new guidelines for the empanelment of healthcare organizations under ESIC.



HLEM emphasized the importance of completing construction projects on time to expand ESIC's medical network and improving partnerships with healthcare organizations to provide enhanced services.

MoS L&E highlighted that the new guidelines for empanelment aim to streamline the process and bring in more reputed healthcare providers. These steps will not only improve healthcare access but also ensure that insured individuals receive timely and quality medical care.



ईएसआईसी द्वारा अस्पतालों के उन्नयन और आयुष इकाइयों की स्थापना की योजना

श्रीमती शोभा करंदलाजे, माननीय श्रम एवं रोजगार राज्य मंत्री ने हाल ही में लोकसभा में बताया कि कर्मचारी राज्य बीमा निगम (ईएसआईसी) देशभर में अपने अस्पतालों को आधुनिक सुविधाओं के साथ उन्नत करने की योजना बना रहा है। इसमें ऑपरेशन थियेटर (ओटी) कॉम्प्लेक्स, नवजात और बाल चिकित्सा गहन देखभाल इकाइयां, विभिन्न प्रयोगशाला सेवाएं, पुनर्वसन क्षेत्र, अत्याधुनिक इमेजिंग सेवाएं और केंद्रीय स्टेराइल आपूर्ति विभाग (सीएसएसडी) / थिएटर स्टेराइल सप्लाय यूनिट (टीएसएसयू) सेवाएं शामिल हैं।

ईएसआई कॉर्पोरेशन ने देश में 105 नए अस्पताल स्थापित करने को सैद्धांतिक मंजूरी दे दी है। ईएसआई कॉर्पोरेशन (ईएसआईसी) ने 10.02.2024 को आयोजित अपनी बैठक में ईएसआई अस्पतालों और औषधालयों में आयुष इकाइयों की स्थापना के लिए मानदंडों को मंजूरी दे दी है। आयुष इकाइयां उन ईएसआईसी / ईएसआई योजना (ईएसआईएस) अस्पतालों और औषधालयों और औषधालय-सह-शाखा कार्यालयों (डीसीबीओ) में सह-स्थान के

आधार पर स्थापित की जानी हैं, जहां दैनिक औसत एलोपैथिक आउटडोर रोगी विभाग (ओपीडी) पंजीकरण पूर्ववर्ती 12 महीने के दौरान 150 से अधिक रोगी हैं। 50 बिस्तरों वाले ईएसआईसी आयुष अस्पतालों को 500 या अधिक बिस्तरों वाले मौजूदा ईएसआई एलोपैथिक अस्पतालों के साथ सह-स्थित किया जाना है, जिनमें से 50 बिस्तर आयुष अस्पताल के लिए निर्धारित किए जाने हैं।

इसके अतिरिक्त, चिकित्सा सेवाओं की गुणवत्ता में सुधार के लिए ईएसआईसी ने स्वीकृत कर्मचारियों की संख्या बढ़ाने, बिस्तरों की संख्या में वृद्धि, राज्यों को वित्तीय और प्रशासनिक स्वतंत्रता प्रदान करने और अतिरिक्त बजट का आवंटन जैसे कदम उठाए हैं।

सुपर स्पेशलिटी सेवाएं जैसे यूरोलॉजी, कार्डियोलॉजी, नेफ्रोलॉजी, प्लास्टिक सर्जरी, ऑन्कोलॉजी, बाल चिकित्सा सर्जरी, गैस्ट्रोएंटरोलॉजी, एंडोक्रिनोलॉजी, रुमेटोलॉजी और न्यूरोलॉजी कुछ मौजूदा ईएसआईसी और टाई-अप अस्पतालों द्वारा प्रदान की जाती हैं।

पूर्वोत्तर क्षेत्रों में ईएसआईसी अस्पतालों और औषधालयों का उन्नयन

हाल ही में लोकसभा में श्रीमती शोभा करंदलाजे, माननीय श्रम एवं रोजगार राज्य मंत्री ने बताया कि असम में दो ईएसआईसी अस्पतालों, बेलटोला (गुवाहाटी) और तिनसुकिया में कुल 41 डॉक्टर कार्यरत हैं। पूर्वोत्तर में तीन डिस्पेंसरी-सह-शाखा कार्यालय, पापुमपारे (अरुणाचल प्रदेश), दारांग (असम) और इंफाल पश्चिम (मणिपुर) में प्रत्येक में एक-एक डॉक्टर नियुक्त हैं। इसके अलावा, राज्यों द्वारा संचालित 41 ईएसआईएस डिस्पेंसरी भी हैं।

ईएसआईसी ने प्राथमिक देखभाल सेवाओं को मजबूत करने के लिए आवश्यक निर्देश जारी किए हैं, कि प्राथमिक देखभाल सेवाओं को मजबूत करने और इन डिस्पेंसरियों को चिकित्सा सेवाएं प्रदान


करने के लिए प्रमुख सुविधाओं के रूप में नामित करने के उद्देश्य से एक डॉक्टर वाली ईएसआईसी संचालित सभी डिस्पेंसरियों में दो डॉक्टर रखे जाएं। इसमें डॉक्टर-रोगी अनुपात में सुधार के लिए कम जनसंख्या घनत्व के कारण बीमित व्यक्तियों की सीमा को कम करना भी शामिल है।

ईएसआई लाभार्थियों को सुपर स्पेशियलिटी चिकित्सा सेवाएं प्रदान करने के लिए अस्पतालों/स्वास्थ्य सुविधाओं का पैनेल ईएसआईसी द्वारा दो वर्षों के लिए बनाया जाता है। इसमें असम में 29 अस्पताल/स्वास्थ्य केन्द्र और मणिपुर, मेघालय और त्रिपुरा में 1-1 अस्पताल/स्वास्थ्य केन्द्र शामिल हैं।

ईएसआई योजना के कामकाज में सुधार के लिए उठाए गए कदम

श्रीमती शोभा करंदलाजे, माननीय श्रम एवं रोजगार राज्य मंत्री ने राज्यसभा में बताया कि कर्मचारी राज्य बीमा अधिनियम, 1948 संगठित क्षेत्र के (मौसमी कारखानों को छोड़कर) सभी कारखानों और प्रतिष्ठानों पर लागू होता है, जिनमें दस या अधिक कर्मचारी हैं और जिनका वेतन 21,000/- रुपये (विकलांग व्यक्तियों के लिए 25,000/- रुपये) तक है।

ईएसआई योजना के लाभार्थियों को अधिक सुविधाजनक और प्रभावी सेवाएं प्रदान करने के उद्देश्य से उठाए गए कदम:

- स्थायी विकलांगता लाभ (पीडीबी) / आश्रितों के लाभ (डीबी) की दरें बढ़ाई गई।

- सेवानिवृत्ति से पहले कवरज से बाहर हुए लाभार्थियों के लिए चिकित्सा देखभाल (एसएसटी सहित) प्रदान करने के लिए नई योजना का प्रस्ताव मंजूर किया गया।
- बीमित व्यक्तियों (आईपी) और उनके परिवार के विवरण के अद्यतन/संपादन के लिए ऑनलाइन मॉड्यूल शुरू किया गया।
- चिकित्सा और नकद लाभ सहित सामाजिक सुरक्षा लाभ प्रदान करने के लिए आधार आधारित प्रमाणीकरण अपनाया गया।
- नकद लाभ दावों के लिए ऑनलाइन पोर्टल / सुविधा शुरू की गई।
- कोविड अवधि के लिए अंशदायी शर्तों में छूट दी गई।

ईएसआई अस्पतालों की संख्या में वृद्धि: पश्चिम बंगाल में नए अस्पतालों की स्थापना

श्रीमती शोभा करंदलाजे, माननीय श्रम एवं रोजगार राज्य मंत्री ने हाल ही में लोकसभा में जानकारी दी कि पूरे देश में 165 ईएसआई अस्पताल हैं। इनमें से 59 अस्पताल ईएसआईसी द्वारा और 106 अस्पताल राज्य सरकारों द्वारा संचालित किये जाते हैं।

देश भर में ईएसआई अस्पतालों की औसत बिस्तर उपयोग दर 46 प्रतिशत है। ईएसआई निगम द्वारा संचालित अस्पतालों की बिस्तर उपयोग दर लगभग 57 प्रतिशत है, जबकि राज्य सरकार

द्वारा संचालित अस्पतालों की दर लगभग 35 प्रतिशत है।

पश्चिम बंगाल के संदर्भ में, श्रीमती करंदलाजे ने बताया कि राज्य के चार जिलों – दार्जिलिंग (सिलीगुड़ी), पूर्वी मेदिनीपुर (हल्दिया), उत्तर 24 परगना (गरश्यामनगर) और पश्चिम मेदिनीपुर (खड़गपुर) में 100 बिस्तरों वाले नए ईएसआई अस्पताल स्थापित करने के लिए सैद्धांतिक मंजूरी दी गई है।

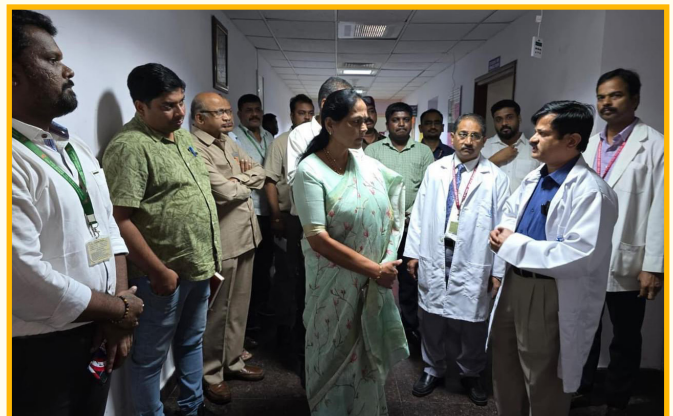

Hon'ble Minister of State Conducts Surprise Inspection at ESI Hospital, Rajajinagar

On 27th August 2024, Mrs. Shobha Karandlaje, Hon'ble Minister of State for Labour and Employment, made an unannounced visit to ESI Hospital, Rajajinagar, to assess the quality of healthcare services provided to the insured workers and their families. The surprise inspection aimed to ensure that the hospital maintains high standards of medical care and operates efficiently to serve the community.

During her visit, MoS L&E conducted a thorough review of critical departments, including the CT and MRI scan units, inpatient and outpatient services and the oxygen plant. She also examined the hospital's processes for handling referral cases, its waste management system and the functionality of the dispensary.



रोजगार सृजन और श्रम सुधार को बढ़ावा देने पर क्षेत्रीय बैठक आयोजित

केंद्रीय श्रम एवं रोजगार राज्य मंत्री, सुश्री शोभा करंदलाजे ने 30 अगस्त, 2024 को बेंगलुरु में कर्नाटक, तमिलनाडु, तेलंगाना, केरल, पुडुचेरी और अंडमान एवं निकोबार द्वीप समूह के साथ एक महत्वपूर्ण क्षेत्रीय बैठक की अध्यक्षता की। इस बैठक में कर्नाटक के श्रम मंत्री श्री संतोष लाड भी उपस्थित थे। यह बैठक श्रम एवं रोजगार मंत्रालय द्वारा सहकारी संघवाद की भावना को सुदृढ़ करने और राज्यों के साथ समन्वय बढ़ाने के उद्देश्य से आयोजित छह

क्षेत्रीय बैठकों की श्रृंखला का पहला चरण था।

बैठक का मुख्य फोकस श्रम सुधारों, ई-श्रम पोर्टल, भवन एवं अन्य निर्माण श्रमिकों (बीओसीडब्ल्यू) के कल्याण और रोजगार सृजन को प्रोत्साहित करने पर था। यह सरकार की कार्यबल के सभी वर्गों के समावेशी विकास और कल्याण के प्रति प्रतिबद्धता को रेखांकित करता है।



अपने संबोधन में, केंद्रीय श्रम एवं रोजगार राज्य मंत्री ने श्रम सुधारों के सफल क्रियान्वयन में राज्यों की महत्वपूर्ण भूमिका पर जोर दिया। उन्होंने कहा कि बैठक का उद्देश्य राज्यों के साथ मिलकर चुनौतियों की पहचान करना, समस्याओं का समाधान निकालना और भविष्य के लिए एक सहयोगात्मक मार्ग तैयार करना था। उन्होंने भाग लेने वाले राज्यों को केंद्र सरकार द्वारा निर्धारित समग्र दृष्टिकोण के साथ

अपने प्रयासों को समन्वित करने का आग्रह किया। इसके अलावा, उन्होंने असंगठित श्रमिकों के कल्याण को सुनिश्चित करने में राज्यों की भूमिका को महत्वपूर्ण बताते हुए, ई-श्रम पोर्टल और अन्य तंत्रों का प्रभावी ढंग से उपयोग करने के लिए राज्य अधिकारियों को प्रेरित किया।



बैठक के दौरान, रोजगार सृजन, रोजगार कार्यालयों के आधुनिकीकरण, शैक्षणिक संस्थानों के साथ साझेदारी और उद्योगों के सहयोग पर विस्तृत चर्चा की गई। इसके अतिरिक्त, कर्मचारी राज्य बीमा निगम (ईएसआईसी) की सेवाओं में सुधार, राज्य स्तरीय

ईएसआईसी सोसायटियों के गठन और निधि प्रवाह को सुव्यवस्थित करने के लिए सर्वोत्तम अवसंरचना के उपयोग पर भी जोर दिया गया।

During her visit, she interacted with patients and beneficiaries and inspected the Dialysis Unit, Operation Theatre and the Cardiology Department, including the Cath-lab.

Secretary Dawra also inaugurated the newly established Physical Medicine and Rehabilitation Unit at ESIC Medical College & Hospital, Sanathnagar, Hyderabad. The unit is equipped with state-of-the-art equipment and specialized services. Additionally, she interacted with the medical students studying the college.

Ms. Sumita Dawra, Secretary (Labour & Employment), chaired a meeting with officials and doctors of ESIC Medical College and Hospital, ESIC Super Specialty Hospital and the Directorate of Medical Services in Hyderabad, Telangana. The discussions covered a wide array of topics, including current healthcare

initiatives, infrastructural developments and future plans to enhance service delivery and patient care.

During her visit, students of ESIC Medical College, Sanathnagar, Hyderabad, interacted with the Secretary to discuss their academic achievements, clinical skills, visions and requirements.



Smt. Sumita Dawra, Secretary, Ministry of Labour & Employment, Government of India Interacts with CII & EFI

Ms. Sumita Dawra, Secretary, Ministry of Labour & Employment, participated in an industry interaction organized by the Confederation of Indian Industry (CII) and the Employers' Federation of India (EFI) on 5th July 2024 in Hyderabad.

During the event, Ms. Dawra highlighted India's fast growth rates and emphasized the importance of the demographic dividend and labour reforms in driving future growth, alongside manufacturing, service sector expansion and infrastructure development.

She cited RBI's KLEMS data, the creation of 8 crore new employment opportunities in the past five years, driven by Government initiatives like PLI, make in India and the growth of the gig economy, which is expected to employ about 2.3 crore people by 2030.

Ms. Dawra discussed the consolidation of 29 Labour Laws into four codes aimed at simplifying regulations and enhancing the ease of doing business. She emphasized the need for expanding social security coverage for the unorganized sector and recognized the governance reforms in ESIC and EPFO.

Presentations on reforms in ESIC and EPFO were also made, focusing on e-governance and compliance simplification. The National Career Service (NCS) portal was showcased, highlighting its role in career counselling and employment networking.

The session, attended by over 300 industry representatives and senior officials was aimed to foster dialogue on employment generation, labour reforms and ease of doing business in India.

for cities/towns classified as X, Y, and Z are 30%, 20%, and 10%, respectively.

Policy for Internet Usage for All ESIC Employees and Officers

The Internet Usage Policy mandates that internet access is for official use only and may be revoked for misuse. Eligibility is determined by the Unit Head or CISO, and sharing credentials or devices is prohibited. Compliance with national laws and the Information Technology Act, 2000 is required, with monitoring

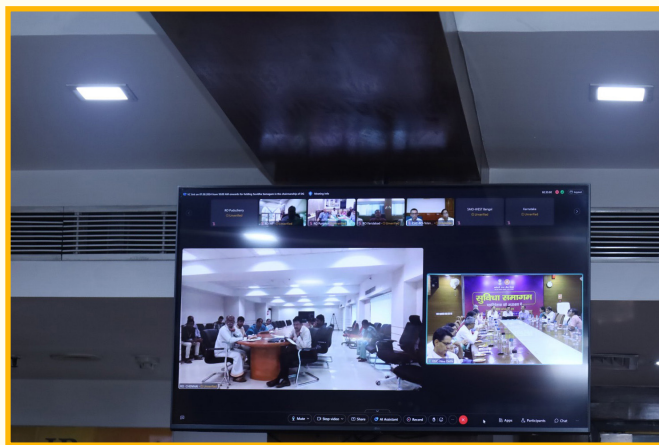
for security purposes. Users are accountable for proper use, and copyright laws must be followed. ESIC is not liable for service interruptions. Mobile devices will have restricted access to the internal network, with exceptions in approved locations. Strict adherence is mandatory, with disciplinary action for violations.

All other terms and conditions outlined in the Government of India Office Memorandum dated 19.07.2017 remain unchanged.

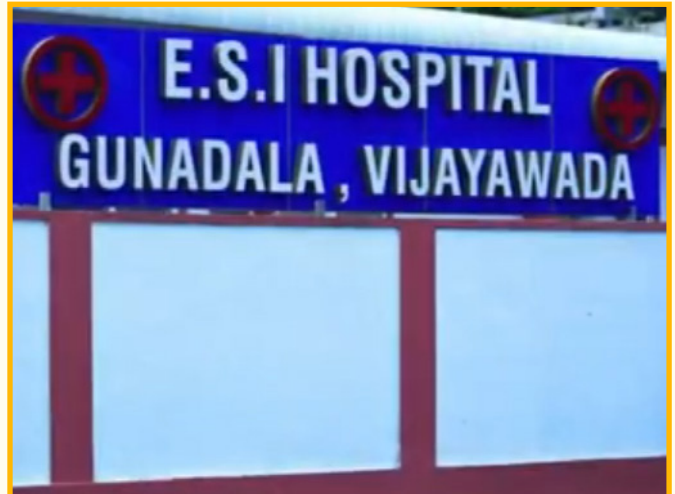

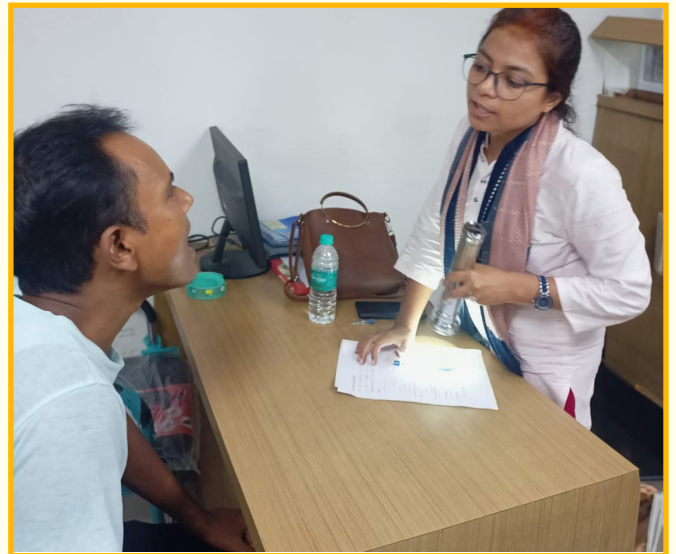

ESIC Introduces Bulk Aadhaar Seeding Facility for Employers

ESIC's ICT Division has launched a new bulk Aadhaar seeding feature on the employer portal, effective from 02.08.2024. This update allows employers to upload Aadhaar details for insured persons and their families in bulk using a downloadable template.

Key Points-

- Ensure Aadhaar details match exactly to avoid seeding issues.
- Beneficiaries needing updates must do so via the IP/

employer portal or ESIC Branch Office, following UIDAI guidelines.

- Minor family members can use the IP/Parent/Guardian's mobile number.
- Do not alter any details in the template; only add Aadhaar and mobile numbers.

This feature complements existing OTP, biometric and face authentication methods. Field offices are advised to review seeding reports and promote this feature to expedite the process.

New Camp-Cum-Liaison Office to Open in Gangtok, Sikkim

The Director General has approved the establishment of a Camp-cum-Liaison Office in Gangtok, Sikkim. Initially, the office will operate from the Branch Office premises in Gangtok, East Sikkim and will serve insured persons across the entire state of Sikkim.

The approved staffing for the office includes Assistant Director (Level 8) – 1 post; Social Security Officer (Level 7) – 1 post;

Assistant (Level 6) – 1 post; UDC (Level 4) – 1 post and MTS (Level 1) – 1 post.

The office will be led by an Assistant Director. The DPC Cell/ Establishment Branch-I of the Headquarters Office will issue orders for this appointment, while the Regional Director, Kolkata, will handle the postings of the Social Security Officer and other officials.

23.05 Lakh New Workers Enrolled under ESI Scheme in May 2024

The provisional payroll data from the Employees' State Insurance Corporation (ESIC) reveals that 23.05 lakh new employees were added in May 2024. This significant increase highlights the expanding reach of the ESI Scheme in providing social security benefits to workers across the country.

Additionally, 20,110 new establishments were brought under the ESI Scheme's social security ambit in May 2024, extending coverage to more workers and ensuring they have access to essential benefits.

A closer examination of the data shows that out of the total 23.05 lakh employees added during the month, 11.15 lakh (approximately 48.37% of the total registrations) are young employees aged up to 25 years. This indicates a substantial proportion of young individuals entering the workforce and becoming part of the social security net.

The gender-wise analysis of the payroll data reveals that 4.47 lakh female employees were newly enrolled in the ESI Scheme in May 2024. Additionally, 60 transgender employees registered under the scheme during the same period. This inclusive approach

demonstrates ESIC's commitment to providing benefits to all sections of society, regardless of gender.

It is important to note that the payroll data is provisional, as data generation is an ongoing process.



ESIC Reports Addition of 21.67 Lakh New Employees in June 2024

According to the provisional payroll data released today by the Employees' State Insurance Corporation (ESIC), 21.67 lakh new employees were added in June 2024.

In addition, 13,483 new establishments were brought under the social security ambit of the ESI Scheme during the same month, expanding social security coverage to more workers.

Year-on-year analysis shows an increase of 1.40 lakh, or 7%, in net registrations compared to the 20.27 lakh new employees registered in June 2023.

The data indicates that out of the total 21.67 lakh new employees added in June, 10.58 lakh, or approximately 49%, are in the age group of up to 25 years.

Gender-wise analysis reveals that 4.32 lakh female members were enrolled in June 2024. Additionally, 55 transgender employees were registered under the ESI Scheme, underscoring ESIC's commitment to providing benefits to all sections of society.

ESIC's Standard Operating Procedure for Prescription Writing

ESIC has formulated a Standard Operating Procedure (SOP) for Prescription Writing to enhance healthcare quality and patient safety. This SOP provides clear guidelines for ESIC doctors using the Dhanwantri module to ensure standardized, patient-specific prescriptions. All prescriptions must include patient details, diagnosis, treatment, and follow-up advice. Issued with the approval of the Competent Authority.

Notification of the Gazette of India: Extraordinary

S.O. 2696(E). - In exercise of the powers conferred by sub-section (3) of section 1 of the Employees' State Insurance Act, 1948 (34 of 1948), the Central Government hereby appoints the 1st day of August, 2024, as the date on which the provisions of sections 38 to 43 (both inclusive), sections 45A, 45AA, 45B, 45C, 45D, 45E, 45F, 45G, 45H and 45I, sections 46 to 73 (both inclusive), section 74 and section 75, sub-section (2) to (4) of section 76, section 82 and section 83 of the said Act shall come into force in all the areas of Bishnupur, Senapati, Ukhrul, Kangpokpi, Churachandpur and Thoubal districts in the State of Manipur.

Policy for Procurement of IT Hardware for ESIC Locations

The following Policy for procurement of IT Hardware has been adopted by ESIC vide letter no. E-323/No. I-11013/4/2021-ICT, Dated 11.07.2024:-

1. Hardware Policy:

A. All-in-One Desktops/Desktop Computers (with Latest Windows OS):

- **General Offices:** One computer per staff, including MTS, not exceeding the sanctioned strength.
- **Hospitals/Dispensaries:** One computer per official; MTS as needed. The maximum number should not exceed sanctioned posts or shift requirements.
- **Medical Colleges/Teaching Institutes:** Assess needs for Computer Labs, Digital Libraries, etc.

B. Multi-functional Machines/Printers:

- **Office Staff:** One Laser Printer/Multifunctional Machine (with scanning) for every 4 staff. Small offices (fewer than 10 staff) should have at least 2 printers. Adjust based on seating proximity.
- **Heads of Offices:** One Colour Laser Printer/Multifunctional Machine for each ZIC, Medical College, NTA/ZTI, ESIC Hospital/Teaching Institute, DMD Office, ROs, SROs, and each Divisional Head at ESIC Headquarters.

C. Switches/LAN Cabling/Nodes:

- Procure switches based on the number of nodes and their locations.
- Handle AMC for existing switches/LAN cabling and node additions through the AMC agency.
- For new offices or relocations, provide LAN and nodes through AMC or fresh work basis following GFR.
- Ensure Wi-Fi in all hospitals and medical colleges per ESIC Wi-Fi Policy dated 28.06.2023.
- Provide physical LAN connections for static devices and Wi-Fi for new premises as per policy.
- Route all Internet/Intranet traffic through SDWAN devices.

D. Scanners:

- Provide two Single Feed Duplex Scanners (A4/Legal Size) with OCR for each RD/SRO/Teaching Institution/Hospital/NTA, and one for each Branch Office and ESIC Headquarters Division.

2. Guidelines for Requirement Assessment:

- Consider actual users and functional needs.
- Assessments to be done by a committee with a Finance representative.
- MTS requirements must be approved by the Head of the Accounting Unit in consultation with Local Finance.
- Special cases require HQ approval.

3. Sanctioning/Procurement Authority:

- **Regional Offices/Branch Offices/DCBOs/ESIC Hospitals:** Regional Director or RD In-Charge.
- **Sub-Regional Offices/Branch Offices:** Director/Deputy Director In-Charge.
- **D(M)D Office and Dispensaries:** Director, Directorate (Medical) Delhi.
- **Director (Medical) Noida Offices and Dispensaries:** Director, Directorate (Medical) Noida.
- **ESIC Hospitals:** Medical Superintendent.
- **Medical Colleges/Teaching Institutes:** Dean/Medical Superintendent.
- **National Training Agency (NTA):** Director, NTA.

4. Procurement Procedure: General Guidelines:

- Procure as per needs and budget, following GFR through GeM.
- Obtain insurance for IT assets.
- Include hardware in AMC post-warranty.
- Record procurement in Dead Stock Register as per GFR.
- Follow attached specifications and ensure compliance with ESIC Cyber Security Guidelines.

This policy is issued with the approval of the competent authority.

Execution of 100% Official Work through E-Office

The Director General mandates 100% execution of official work through E-Office. Matters needing Headquarters' approval must be processed on E-File by the relevant offices. Requests for

guidance should be sent via email. All offices must use E-Office for internal correspondence.

Creation of Special Desk for ESIC Beneficiaries at Empaneled HCOs

The Competent Authority has directed all ESIC-empaneled hospitals to set up a special ESIC Desk to ensure hassle-free cashless treatment for ESIC beneficiaries. Instructions for this are to be issued to all empaneled Healthcare Organizations (HCOs). This notification is approved by the Medical Commissioner.

Observance of Punctuality by Officers/Officials at ESI Corporation Offices

Reference to HQ Circular No. Z-17/12/7/Misc/2022E.IPart dated 16-06-2024 for punctuality and AEBAS attendance guidelines. Habitual lateness and early departures may lead to disciplinary action. All officers and officials must adhere to these guidelines. Heads of Offices and Controlling Officers should supervise and conduct surprise checks to ensure compliance. Approved by the Competent Authority.

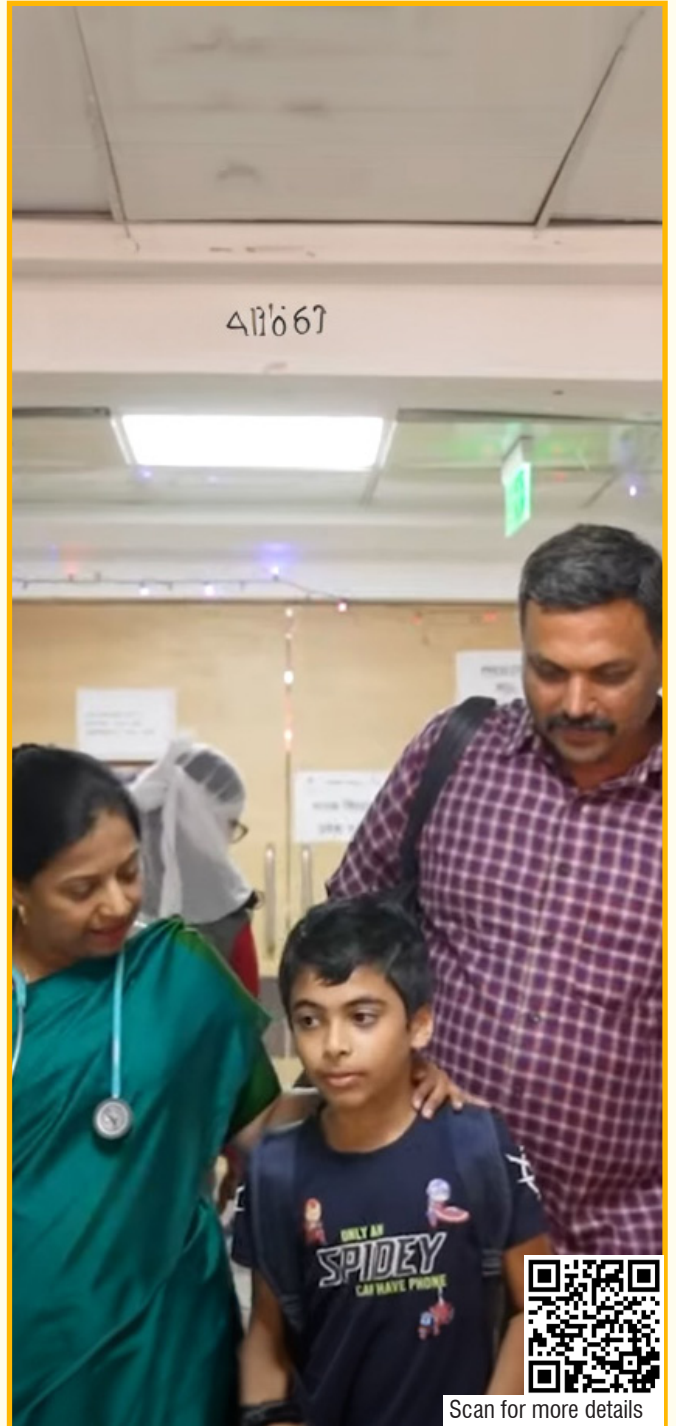
