In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. The Prospective bidders are hereby encouraged to participate in the pre-bid meeting to eliminate any a mbiguity or doubt regarding the bid documents. Nonparticipation in the pre-bid meeting will be deemed as an acceptance that the bidder has no doubts or ambiguities about the terms and conditions of the bid and has fully understood the essence of bid documents. Consequently, after the award of the contract, no furth er questions, clarifications, or requests for modifications will be entertained, and the bidder will be obligate d to comply with all terms and conditions of the bid and in any circumstances the discretion of Medical Sup erintendent of ESIC Hospital Rudrapur will be final.

- B. In the event of any conflict or inconsistency between the provisions of the GeM bid and the terms and conditions outlined in the ATC, the provisions of the ATC shall prevail.
- C. Bidder has to upload all the mandatory documents as indicated under "Bidder's& OEM Eligibility Criteria " on either NIT/ bid P/g No 8 and/ or as given below otherwise bidders candidature will be rejected: (bidder must submit following documents otherwise bidder will be rejected).
- 1. The bidder or the OEM should not be blacklisted by ESIC or any other Central/State/ PSU/ Govt organizati ons. A certificate or undertaking to this effect must be submitted.
- 2. Bidder must be a valid registration of firm certificate or licence or incorporation or affidavit must be sub mitted for proof of firm.
- 3. Annual turnover of the bidder should be not less than 40% of estimate amount during last three (3) finan cial year. (MSME or Start up is relaxed as per Govt Norms).
- 4. Copy of EMD/Exemption Certificate.
- 5. Completion Certificate of Work or credential duly signed by competent authority (Govt./PSU).
- 6. Certificate of Registration for Goods and Service Tax (GST).
- 7. Copy of Pan Card.
- 8. Annual Turnover Certificate Dully Certified by CA (FY 20-21, 21-22, 22-23).

- 9. Audited Balance sheet & Profit and Loss Account statement of the bidder (FY 20-21, 21-22, 22-23).
- 10. ITR of last three years (FY 20-21, 21-22, 22-23).
- 11. OEM Authorization Certificate in case of Authorized vendor of OEM participating the bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract

### and Buyer may take suitable actions as per GeM Contract.
